The After-School Division consists of 22 TEAM UP school-based sites, and a Community-Based After-School Program. Each quality after-school program site provides academic support and enrichment activities in a safe environment where students can thrive during after school hours, at no cost to the students and their families. The program starts with a snack, finishes with a hot evening meal and includes academic instruction for one hour each day by a certified teacher in language arts, science and math. In addition, students participate in enrichment activities such as choir, dance, sports and symphony instruction.

4b (Code:) (Expenses \$ 1,991,269 including grants of \$) (Revenue \$ 2,052,855)

The Case Management Division consists of the Student Enrichment, Bridge to Success, and Achievers for Life programs which embed site coordinators directly into the schools to provide critical services to students who are at-risk of falling behind or dropping out of school. Student Enrichment Program, an original program, places full-time Site Coordinators on school campuses throughout Duval County. Site Coordinators work with select students from the school and counsel them in individual and group sessions throughout the year. Site Coordinators enable students to realize their goals and provide them with life skills they need to reach their goals. Bridge to Success Site Coordinators work with students who are overage for their grade level. Site Coordinators address all barriers to graduation and

Duval Reads is a literacy program that provides intensive one-on-one and small group tutoring sessions to students who are reading below grade level from kindergarten through ninth grade. This program has 32 AmeriCorps members who serve over 400 students in 16 schools. The goal of the program is to increase students' reading levels. Duval Reads also provides the DREAM Project (Duval Reads Engaging America's Military). This bold new initiative engages veterans, military dependents and active servicemen as volunteer mentors and tutors to students served by Communities In Schools.
